



GVMPO Annual Listing of Federally Obligated Projects – Federal Fiscal Year 2021

Federal law, as required by the Moving Ahead for Progress in the 21st Century Act (MAP-21, P.L. 112-141) and the Fixing America's Surface Transportation Act (FAST Act, P.L. 114-94), require the Grand Valley Metropolitan Planning Organization (GVMPO) to make available for public review an annual listing of transportation projects for which federal funds have been obligated in the preceding year. This includes roadway, bicycle, pedestrian, planning, and transit projects where the federal funding passes through the Colorado Department of Transportation (CDOT). This document serves as a record of project delivery and as a progress report for public information and disclosure.

This report lists each project that received federal funding during Federal Fiscal Year (FFY) 2021 and includes a brief description of the project and funding amounts. Data includes amounts for advance construction and obligations.

Roadway, transit and planning projects totaled to approximately \$7.56 million in obligated federal funds for transportation projects within the GVMPO and Grand Valley Transportation Planning Region between October 1, 2020 and September 30, 2021. Additionally, approximately \$5.64 million in Advanced Construction funding was programmed by CDOT.

Definitions

Obligation - An obligation is the federal share of a project's cost that is a legal commitment given by the Federal government to agencies for project development. In some cases, the cost of the project will exceed the obligated amount that was allocated. Obligated projects do not guarantee that a project has been initiated or completed.

Program Year - The project listing shows project obligations reported from the previous Federal fiscal year.

Project Description/Title - The project boundaries and extent of construction and corresponds to listings in the Transportation Improvement Program (TIP).

Funding Program - The name and description of the funding source allocated to the project.

Obligation Amount - The sum amount of federal dollars obligated to the project for the fiscal year.

Advanced Construction (ADVC) - A technique that allows the Colorado Department of Transportation (CDOT) to initiate a project using non-federal funds while preserving eligibility for future Federal-aid funds. After an advance construction project is authorized, the State may



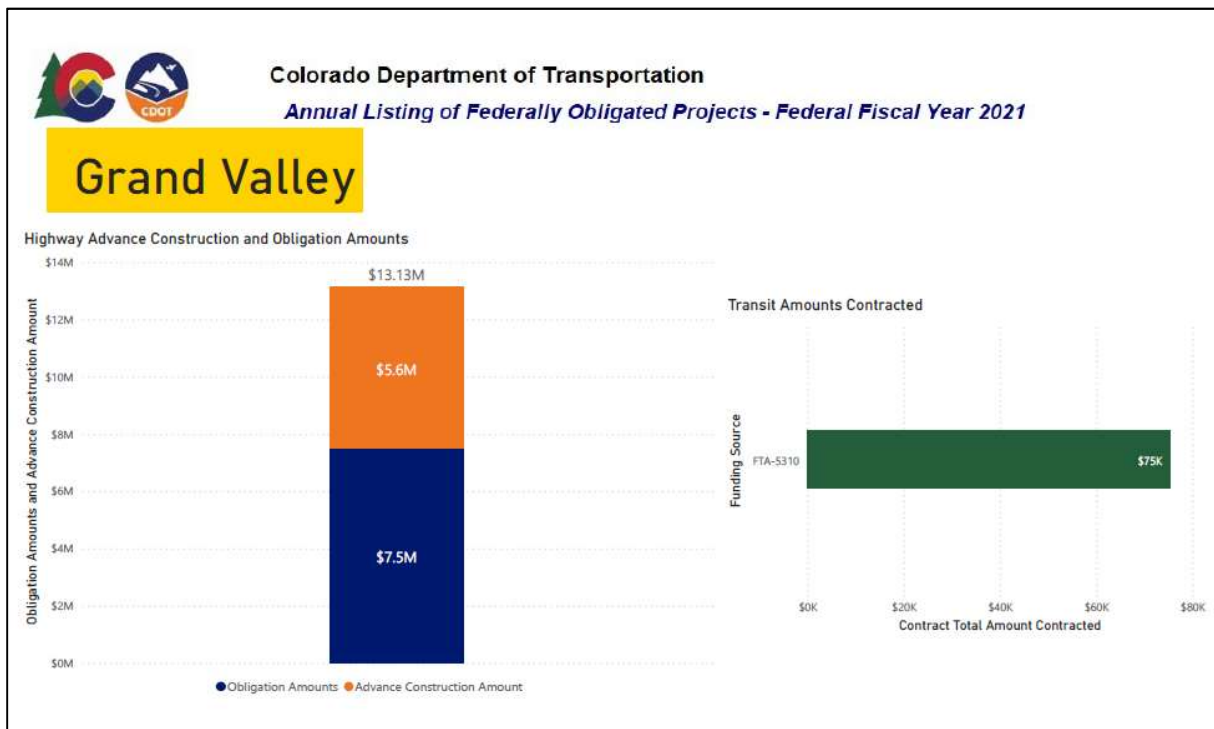
convert the project to regular Federal-aid funding provided Federal funds are made available for the project. This practice is used in anticipation of future federal funds. When ADVC amounts are shown as negative, for example (\$XX.XX), and there is a corresponding positive entry in the Obligation Amounts column, that indicates that federal funding became available and was subsequently obligated.
